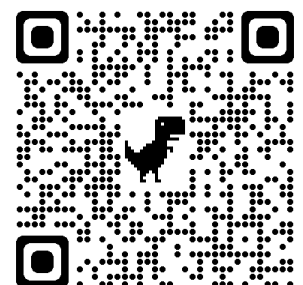

CHILI COMPETITION RULES:

- **This is a Home Style Chili Competition. This means the recipe could consist of:** Meat, a combination of meats, or a vegetable base, cooked with red or green chili peppers, various spices and other ingredients, such as but not limited to: beans, garlic, onions & herbs.
- Check-in time will be Saturday, June 1st, starting at 6:00 AM until 12:00 PM.
- No vehicles will be allowed in or out between 12:00 PM and 4:00 PM Saturday except for emergencies. Vehicles allowed in the cooking area for equipment drop-off only. Vehicles must be removed after drop-off.
- No pets are allowed on premises, no exceptions.
- Contestants must supply all needed equipment and supplies, including but not limited to:
 - Table(s), Chair(s) & a Pop-Up tent for shade (12 ft x 12 ft space will be outdoors)
 - Food safe cleaning equipment, Food service gloves, Hand & Surface Wipes
 - If using flame-based heating methods, **DO NOT DUMP** your coals on the ground (we will provide metal can for hot coals), all fires must be in containers, Fire extinguisher for their space: minimum rating of 5lb type AB, Meat thermometer are required by the Health Dept.
- All teams must follow all Sonoma County Department of Health codes and regulations. Prepare and cook your chili in a sanitary manner. Your cooking conditions are subject to inspection by local health authorities. Teams found serving undercooked meat, handling/storing food unsafely or using other unsafe techniques will be disqualified.
- All contestants agree to have a minimum of 4 gallons of chili (no maximum) cooked and ready to serve by 12:00 PM. Judges turn-in time is 12:00 PM.
- A 32-oz cup & lid will be provided to be filled with chili for the judges to sample. All judges will use disposable spoons to taste while sampling. See attached judging sheet for the criteria judges will adhere to.
- Garnishing is encouraged, but not all judges may choose to partake in the garnish; teams are encouraged to submit a chili that can stand on its own.
- Winners will be announced no later than 4:00 p.m.
- Teams will be provided a 2 oz. sample cups, sample spoons and napkins. Teams are not obligated to use the provided cups or spoons; you are welcome to bring your own if preferred.
- Absolutely no firearms or explosives will be allowed.
- Each team will be responsible for cleanup of their space.
- The Chief Cook will be responsible for the conduct of his/her team and guests.
- **Festive presentation, decoration and costumes are encouraged!**
- Absolutely NO outside alcohol allowed. Alcohol must be purchased the day of the event
- Petaluma Active 20-30 reserves the right to make additional rules as necessary.
